Expenses included cupboard supplies, gift cards for the card party, confirmation gifts, and the steam iron (for environment).</p> <p>Nancy reported the final net income for the Fall Dinner is \$7,103.61.</p>	<p>Final net income from Fall Dinner – \$ 7,103.61.</p> <p>Donna Bloom Hiphner moved and Mary Ludwig seconded acceptance of financial report as presented. Motion carried.</p>
OLD BUSINESS	<ul style="list-style-type: none"> ➤ <u>Table Cloth Fabric</u> Further discussed purchasing the table cloth fabric considered at the last meeting. Judy DeWitz brought the sample of fabric which she had tested for staining with various foodstuffs (ketchup, grease, coffee). The fabric was easily cleaned by washing in a regular wash cycle. It was determined 12 tablecloths could be made from 3 bolts of this fabric. ➤ <u>Card Party</u> President Reichert announced that the February party will be changed from its regular date of the second Sunday to February 19th due to a scheduling conflict. <p>Attendance at the November party was 31. The next party will be held on its scheduled date of December 10. President Reichert and Nancy Morth will serve.</p> <ul style="list-style-type: none"> ➤ <u>Funeral Servers</u> President Reichert tentatively plans to hold a training for the new funeral servers on December 2. She is still making scheduling plans for the meeting. 	<p>Mary Ludwig moved and Mary Bartsch seconded 3 bolts of the fabric be purchased to make cloths to cover 12 eight foot tables. Motion carried.</p> <p>February Card Party will be held February 19th (change of date).</p> <p>Alvina prepared the advertisements for the December event. Judy will deliver them to the local churches and Senior Center.</p> <p>Alvina is tentatively planning to hold a Funeral Server training session on December 2.</p>
